#### **ISO 9001 HISTORY**

Noridian has been certified to ISO 9001 since September 5, 2014, and is a single-site facility headquartered in Fargo, ND.

Noridian's current certification cycle started September 5, 2023, and the cycle expiration date is September 4, 2026.

#### **COMPANY BACKGROUND**

Noridian Healthcare Solutions, LLC (Noridian) is headquartered in Fargo, N.D., employing approximately 2100 employees throughout the country. Noridian provides healthcare administration support services and has extensive experience in claims management, medical review, contact centers, and provider management.

Noridian is the Medicare Administrative Contractor (MAC) for Medicare Parts A/B for Jurisdictions E and F, the Durable Medical Equipment MAC (DMEMAC) for Jurisdictions A and D, and the Supplemental Medical Review Contractor (SMRC).

#### **DESCRIPTION OF SERVICES**

Noridian is soliciting a company to provide the following ISO 9001 audit and related services.

#### **ISO 9001 Internal Audits**

Internal auditing consists of auditing performed in preparation for the ISO 9001 recertification/surveillance assessment. The auditing work will not exceed five (5) days per week. Most, if not all, audit services will be provided offsite. If necessary, audit services It may be provided onsite, upon request of Noridian. Onsite means performed at Noridian's headquarters in Fargo, ND. Offsite is at a site other than Noridian headquarters.

Vendor agrees to provide internal audit reports within one week of the conclusion of each internal audit.

Number of Days Annually may vary due to multiple variables including, but not limited to, increase in services provided, or combination of processes.

#### ISO 9001 Consulting

Consulting consists of providing consulting support for Noridian in the form of meetings, direction, advice, consultation, and awareness training of the ISO 9001 standard. The consulting activities may include:

- Attending meetings
- Conducting reviews of documents and records
- Documentation review
- Generating and modifying written documented procedures in connection to the ISO 9001 and Noridian Quality Management System.
- Advising and providing information on process operations and best practices.
- Advising and providing information on quality management systems, including conformance to ISO 9001
- Any other work as directed and approved by the Noridian ISO coordinator.
- Advising and providing support during certification body assessments.

Consulting work will not exceed five (5) days per week. Most, if not all, consulting services will be provided offsite. If necessary, consulting services may be provided onsite, upon request of Noridian. Onsite means performed at Noridian's headquarters in Fargo, ND. Offsite is at a site other than Noridian headquarters.

#### ISO 9001 Consulting

Consulting will coincide with Noridian's annual certification/recertification or surveillance assessments conducted by a certification body. and may occur onsite or offsite as approved by Noridian. Onsite means performed at Noridian's headquarters in Fargo, ND. Offsite is at a site other than Noridian headquarters. The consulting work will not exceed five (5) days per week.

The objective of consulting is to provide expertise in the application of the ISO 9001 requirements to the Noridian situation, to answer questions, to negate or minimize any negative audit findings and to advise

on procedural matters of the audit. Advice and support will be provided directly to Noridian personnel and Continuous Improvement & Quality Assurance personnel approved to interact with the certification body auditors. Vendor agrees to help Noridian with any findings presented during the assessments and in any draft and final reports, both in terms of defending against the findings and assisting with response to the findings.

#### Requirements:

The ability to perform services remotely using a Microsoft Teams meeting or other Noridian-approved tool. All meetings will be organized by Noridian.

- Auditors must meet or exceed the requirements of the ISO 19011 standard.
- Vendor is required to submit background check certificates for its Auditors performing work for Noridian at vendor expense. All Vendor Personnel shall be pre-approved by Noridian prior to performing services.
- Vendor will provide auditor bios upon request. The bios will include, at a minimum, the auditor's work experience and verification of current certifications.
- Vendor will provide evidence of meeting Noridian's standard insurance requirements as indicated in Attachment A:
- In order to provide read-only access to Auditor of the Noridian ISO Audit evidence, Microsoft Teams meetings will be used to allow for sharing of Noridian evidence via screenshare on Noridian laptops or, alternately, Auditor's laptops may be used for this communication. Auditor laptops or computers must be protected according to requirements laid out by Noridian. No Noridian proprietary, sensitive, or higher classification of information will be retained, copied by Auditor.
- Noridian evidence provided to the auditor will not be retained or copied by the auditor.

#### **Insurance Requirements**

- Commercial General Liability covering bodily injury and tangible property damage liability (including coverage for products / completed operations) with a limit of not less than U.S. \$2,000,000 each occurrence;
- 2. Workers' Compensation (or maintenance of a legally permitted and government-approved program of self-insurance) covering Vendor pursuant to applicable state workers' compensation laws for work-related injuries suffered by Vendor;
- 3. Employer's Liability with limits of not less than U.S. \$1,000,000 per incident;
- 4. Professional Liability/Errors & Omissions Liability covering damages arising out of negligent acts, errors, or omissions committed by Vendor in the performance of Services, with a liability limit of not less than U.S. \$2,000,000 per claim;
- 5. Automobile Liability (if vehicles are brought on Noridian's premises or used in the performance of the Services) for bodily injury and property damage combined, covering owned, non-owned and hired vehicles, with \$1,000,000 combined single limit per occurrence; and
- 6. Cyber liability insurance with a minimum limit of \$10,000,000 for each and every claim and in the aggregate covering liabilities for loss resulting or arising from acts, errors, or omissions in the rendering of, in the failure to render or otherwise in connection with the services provided under this Agreement, which shall include coverage for:
  - a. Violation or infringement of any right, including copyright, trademark and privacy right or of the Nondisclosure Agreement.
  - b. Breach of federal, state, or foreign security and/or privacy laws or regulations.
  - c. Data theft, damage, destruction, or corruption, including without limitation: (1) unauthorized access, use or dissemination of private information; (2) identity theft; (3) theft of personally identifiable information or confidential corporate information; (4) transmission of a computer virus or other type of malicious code; and (5) participation in a denial of service attack on a third party.
  - d. Breach response coverage, including without limitation forensic and legal assistance, notification costs, credit monitoring services for each person notified, loss prevention services and identity theft-related fraud resolution services.

Cyber Liability coverage must include contractual liability coverage for the confidentiality/data breach indemnity requirement in this Agreement.

Cyber liability insurance must cover all of the foregoing without limitation if caused by Vendor's Personnel, including an employee, agent, independent contractor or business associate working on behalf of Vendor in connection with this Agreement.
